He was an Associate Professor in Economics in Chinese University of Hong Kong from 1995 to 2009. Dr. Kwan is dedicated in the research area of Financial Economics, Econometrics, and Time Series Analysis. He published more than 30 academic papers in various journals and served as a reviewer for Pearson Addison Wesley (UK) and nearly 30 international academic publications. Dr. Kwan is now a member of the Hong Kong SAR Public Affairs Forum and a member of the Long-Term Housing Strategy Steering Committee.

Mr. Jasper Lo is currently the Senior Vice President of iBest Finance in HK with over 30 years of working experience in financial sector. He served as department head in a number of listed financial institutions and foreign banks in HK. His specialization is in trading commodities, fund investment and technical analysis. Mr. Lo is also a visiting lecturer in Hong Kong and China's well-known universities, giving talks and courses related with investment and is appointed as Chief Training Consultant by mainland securities firm.
