綠色金融，作為當今全球經濟發展的一個重大趨勢，已經成為實現可持續發展的必由之路。早於2018年，國家就已在“一帶一路”倡議中提出綠色投資原則，制定綠色投資目標，積極推動經濟社會可持續發展，以實現社會福利最大化。

為促進經濟適度多元及可持續發展，澳門特區政府正在加快實施“1+4”適度多元發展策略，積極發展現代金融，善用“一中心、一平台、一基地”的定位，充分發揮澳門的特殊優勢，推動綠色金融的建設，從而增強澳門經濟的發展動能。

為此，今年的研討會以“綠色金融 – 企業永續發展的新動力”為主題，與大家共同探討如何在綠色金融的框架下，推動澳門企業的永續發展，完善綠色金融體系。

Green Finance is a new but rapidly expanding area of financial activities in line with the global trend of implementing the sustainable development goals. The Green Investment Principles for the Belt and Road was launched in 2018 by the country to accelerate green investments in the Belt and Road Initiative, set green investment targets, and to actively promote sustainable social and economic development to accomplish social welfare maximization.

With the aim to facilitate adequate economic diversification and sustainable development, the Macao SAR Government is committed to the development strategy of “1+4” adequate diversification to support Macao in expanding and deepening the development of modern financial services, closely aligns with Macao’s strategic positioning as “One Centre, One Platform, One Base” and taking advantage of Macao’s specific advantages, further promoting the development of green and sustainable finance and thus Macao’s impetus for development will be strengthened on an ongoing basis.

This year’s conference is conducted theming “Green Finance: New Driving Force for Development of Corporate Sustainability” with a view to exploring initiatives to expedite sustainable development of industries in Macao and enhancement of green financial system under the Green Financing Framework.

## 簡介 Introduction

隨著全球對環境問題及可持續發展的關注不斷加強，綠色金融已成為一種融合金融和環保的新型金融模式，逐漸成為全球關注焦點。近年來，國家逐步加強對綠色金融的支持和引導，並推出了一系列相關政策和措施，其中包括中國銀行保險監督管理委員會制定的《銀行業保險業綠色金融指引》，為國家綠色金融產業提供了政策基礎和市場保障。

作為粵港澳大灣區區域發展的“核心引擎”之一，澳門在綠色金融發展中有著無限的潛力和空間。在《澳門特區政府經濟和社會發展第二個五年規劃（2021至2025年）》中，特區政府明確將“探索綠色金融和建立綠色金融平台”列為優先工作，通過綠色轉型，澳門企業可實現經濟、社會和環境的三重效益，同時降低企業的風險和負擔。

今年研討會的主題為“綠色金融 – 企業永續發展的新動力”，我們非常榮幸邀請到中港澳金融業專家擔任講者嘉賓，共同探討綠色金融的發展趨勢和實踐經驗，期望能為本地企業的發展路向帶來啟發，善用綠色金融工具，實現企業可持續發展，促進澳門產業多元化及社會競爭力。

With notable global increase in attention to environmental issues and sustainable development, green financing has become a new financing model that integrates financial and environmental protection factors which has gradually been put into the global spotlight. In recent years, the country has been proactively strengthened its support and guidance for green finance, and a series of related policies and measures have been launched, including that the “Guidelines for Green Finance of the Banking and Insurance Industries” issued by the China Banking and Insurance Regulatory Commission, optimizing the green financial sector of the country in terms of reinforcement of policy support and control as well as market safety mechanisms.

As one of the core engines for regional development of the Guangdong-Hong Kong-Macao Greater Bay Area, Macao has unlimited development potentials in its green financial sector. According to “The Second Five-Year Plan for Economic and Social Development of the Macao SAR Government (2021–2025)”, the Government will pragmatically forge ahead and prioritize on “exploring green finance and establishing green finance platform”. With the green transformation approach, Macao enterprises could achieve triple benefits of economic, social and environmental growth while minimizing the risks and burdens places on businesses.

The theme of this year’s conference is “Green Finance: New Driving Force for Development of Corporate Sustainability”. We are honored to have invited experts in financial sectors from Mainland China, Hong Kong and Macao to explore subjects ranging from the development trends and their practical experiences of green finance, aiming to offer insights and to bring inspiration to local enterprises, utilizing green financial instruments for corporate sustainability, to promote diversified emerging local industries and to boost Macao’s overall competitiveness.
